

## Hudson County Shouts Down Drugs

### Copyright License and Release

This Copyright License and Release is made effective as of the latest date written below by and among Partnership for a Drug-Free New Jersey, a New Jersey not-for-profit corporation with offices at 185 Fairfield Avenue, Suite 4C, West Caldwell, New Jersey 07007 (“PDFNJ”) and \_\_\_\_\_ “Licensor”.

WHEREAS, PDFNJ is sponsoring a music/rap competition in cooperation with United Way of Hudson County, to be held between high school students in the County of Hudson and called *Hudson County Shouts Down Drugs* (the “Competition”);

WHEREAS, Licensor is a participant in the Competition, who will submit a song to be judged in the Competition;

WHEREAS, the song selected as the countywide winner will be produced by the PDFNJ for distribution to, and possible play by, New Jersey radio stations.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, PDFNJ and Licensor hereby agree as follows:

1. Creation of Works/Power and Authority

In the course of participating in the Competition, Licensor has created an original song (the “Work”). Licensor represents and warrants that the Work in its entirety is the original creation of Licensor, that Licensor has the full and unrestricted right<sup>1</sup> to enter into this agreement and to grant to PDFNJ all of the rights granted to PDFNJ herein. Licensor further warrants that PDFNJ’s exercise of its rights granted by Licensor shall not infringe upon the copyright or other property, privacy or contractual right, or other rights of, or constitute unfair competition with, any third party.

2. License of Rights of Copyright

Licensor hereby grants PDFNJ an irrevocable, non-exclusive, worldwide license to use, reproduce, prepare derivative works based upon, distribute copies of, publicly perform, and to perform publicly by means of a digital audio transmission, the Work or excerpts therefrom including the lyrics, music, or both, including without limitation the

right to perform and/or broadcast the Work by radio broadcasting, television, or any and all means, whether now known or which my hereafter come into existence, without charge or royalty, provided that all such uses by PDFNJ are solely in connection with the promotion, marketing and/or advertisement of PDFNJ and its anti-drug public service messages.

3. Release/Indemnity

Licensor and Licensor's successors and assigns hereby release and forever discharge PDFNJ and its successors and assigns, and its former, present and future parents, subsidiaries, officers, directors, shareholders and employees, from any and all causes of action, liabilities, debts, damages, judgments, executions, rights, obligations and any claims whatsoever, including, but not limited to, claims for compensation of any kind in connection with PDFNJ's use of the Work as set forth herein.

Licensor shall indemnify and hold PDFNJ its successors, assigns, and licensees harmless from and against any and all claims made for, or losses, liabilities and expenses, including without limitation reasonable attorneys' fees incurred arising from any breach of any of the representations or agreements of Licensor herein.

4. Use by the Licensor

This agreement in no way prevents Licensor from using or licensing the Work in any manner Licensor sees fit, provided that any subsequent sale, licensing, or other transfer by Licensor of rights in the Work shall be subject to and limited by the rights granted to PDFNJ herein.

5. Entire Agreement

All agreements, covenants, representations and warranties, expressed or implied, oral or written, of the parties hereto concerning the subject matter hereof are contained herein. No other agreements, covenants, representations or warranties, express or implied, oral or written have been made by any party hereto to any other party concerning the subject matter hereof. All prior and contemporaneous conversations, negotiations, possible and alleged agreements, representations, covenants and warranties concerning the subject matter hereof are merged herein. This is an integrated agreement.

6. Authority

Licensors have full legal authority and ability to sign this agreement on their own behalf and represents that Licensor is at least 18 years of age. If Licensor is younger than 18 years of age, Licensor's parent or legal guardian represents that he/she has full legal authority and ability to sign this agreement on behalf of Licensor.
