## **BOROUGH OF BRIELLE**

ORDINANCE NO. 908

AN ORDINANCE TO AMEND CHAPTER VI OF THE CODE OF THE BOROUGH OF BRIELLE ENTITLED "ALCOHOLIC BEVERAGES".

BE IT ORDAINED BY THE GOVERNING BODY OF THE BOROUGH OF BRIELLE THAT CHAPTER VI OF THE CODE OF THE BOROUGH OF BRIELLE SHALL HEREBY BE AMENDED AS FOLLOWS:

Chapter VI Section 5 is hereby amended to include a new section 6-5.6 (a) to read as follows:

No person shall offer or serve alcoholic beverage to a person under legal age in any public or quasi-public place within the Borough of Brielle. No person who has ownership or control of any premises, whether public or quasi-public, or supervision of any event, shall permit, suffer or allow the consumption of an alcoholic beverage by a person under legal age in or upon any such premises or at any such event within the Borough of Brielle.

Chapter VI Section 5 is hereby further amended to include a new section 6-5.6 (b) to read as follows:

The possession or consumption of alcoholic beverages by underage person(s) on private property is hereby prohibited. It is hereby unlawful for any person(s) under the legal age to, without legal authority, to knowingly possess or knowingly consume an alcoholic beverage on private property.

(Exceptions) This ordinance shall not prohibit an underage person from consuming or possessing alcoholic beverage in connection with a religious observance, ceremony or rite or consuming or possessing an alcoholic beverage in the presence of and with the permission of a parent, guardian or relative who has attained the legal age to purchase and consume alcoholic beverages.

## ORDINANCE NO.

This ordinance shall not prohibit the possession of alcoholic beverages by any underage person while actively engaged in the performance of employment by a person who has license under Title 33 of the revised statutes of New Jersey, or while actively engaged in the preparation of food while enrolled in a culinary arts or hotel management program at a county vocational or post-secondary educational institute; however, this ordinance shall not be construed to preclude the imposition of a penalty under N.J.S.A. 33:1-81,or any other section of the law against a person who is convicted of unlawful alcoholic beverage activity on or at premises licensed for the sale of alcoholic beverages.

(Definitions) For the purpose of this amendment the following definitions shall apply.

GUARDIAN - a person who has qualified as a guardian of the underage person pursuant to a testamentary or court appointment.

RELATIVE - shall mean the underage person's grandparent, aunt or uncle, sibling, or any other person related by blood or affinity.

BE IT FURTHER ORDAINED, that all Ordinances or parts of Ordinances, inconsistent with the foregoing are hereby repealed, but only to the extent of the inconsistency.

BE IT FURTHER ORDAINED, that this Ordinance shall take effect immediately upon passage and publication according to law.
