ORDINANCE NO. 03-2010

**AN ORDINANCE OF THE CITY OF ESTELL MANOR
MAKING IT UNLAWFUL FOR ANY PERSON UNDER THE
LEGAL AGE TO KNOWINGLY POSSESS OR KNOWINGLY CONSUME
AN ALCOHOLIC BEVERAGE ON PRIVATE PROPERTY WITHOUT LEGAL
AUTHORITY AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF**

WHEREAS, the City Council of the City of Estell Manor have determined that it is for the best interest of the City and will promote public safety to enact an ordinance making it unlawful for any person under the legal age who, without legal authority, knowingly possesses or knowingly consumes an alcoholic beverage on private property and provides for the assessment of penalties including the suspension, revocation or postponement of certain driving privileges;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Estell Manor, County of Atlantic and State of New Jersey that:

SECTION 1. There is established in the City of Estell Manor an Ordinance regulating underage drinking on private property, which shall provide as follows:

1. **UNDERAGE CONSUMPTION.** It shall be unlawful for any person under the legal age who, without legal authority, knowingly possesses or knowingly consumes an alcoholic beverage on private property.

2. **PENALTY.** Any person violating the provisions of this Ordinance shall, in accordance with the provisions of N.J.S.A. 40:48-1 as amended, be punished by a fine of \$250.00 for a first offense and \$350.00 for any subsequent offense.

3. **ADDITIONAL PENALTIES.**

3.1 In addition to the fine authorized for this offense, the Court may suspend or postpone for six (6) months the driving privilege of the defendant. Upon the

conviction of any person and the suspension or postponement of that person's driver's license, the Court shall forward a report to the Division of Motor Vehicles starting the first and last day of the suspension or postponement period imposed by the Court pursuant to N.J.S.A. 40:48-1 as amended. If a person at the time of the imposition of sentences is less than 17 years of age, the period of license postponement, including a suspension or postponement of the privilege of operating motorized bicycle, shall commence on the day the sentence is imposed and shall run for a period of six (6) months after the person reaches the age of 17 years.

- 3.2 If a person at the time of the imposition of a sentence has a valid driver's license issued by this State, the court shall immediately collect the license and forward it to the Division of Motor Vehicles along with the report. If for any reason the license cannot be collected, the Court shall include in the report the complete name, address, date of birth, eye color, and sex of the person, as well as the first and last date of the license suspension period imposed by the Court.
- 3.3 The Court shall inform the person orally and in writing that if the person is convicted of operating a motor vehicle during the period of license suspension or postponement, the person shall be subject to the penalties set forth in R.S. 39:3-40. A person shall be required to acknowledge receipt of the written notice in writing. Failure to receive a written notice or failure to acknowledge in writing the receipt of a written notice shall not be a defense to a subsequent charge of a violation of R.S. 39:3-40.
- 3.4 If a person convicted under this Ordinance is not a New Jersey resident, the Court

shall suspend or postpone, as appropriate, the non-resident driving privilege of the person based on the age of the person and submit it to the Division of Motor Vehicles on the required report. The Court shall not collect the license of a non-resident convicted under this Ordinance. Upon receipt of a report for the Court, the Division of Motor Vehicles shall notify the appropriate officials in the licensing jurisdiction of the suspension or postponement.

4. **EXCEPTIONS:**

4.1 Nothing contained in this Ordinance is intended, nor shall it be construed, as prohibiting an underage person from consuming or possession an alcoholic beverage in the presence of and with the permission of a parent, guardian or relative who has attained the legal age to purchase and consume alcoholic beverages.

4.2 As used in the preceding Section (Section 4.1 hereof), the following terms shall have the meaning set forth:

“Guardian” means a person who has qualified as a guardian of the underaged person pursuant to testamentary or court appointment;

“Relative” means the underaged person’s grandparent, aunt, or uncle, sibling, or any other person related by blood or affinity.

4.3 Nothing contained in this Ordinance is intended nor shall it be construed as prohibiting possession of alcoholic beverages by any such person while actually engaged in the performance of employment by a person who is licensed under Title 33 of the Revised Statutes, or while actively engaged in the preparation of food while enrolled in a culinary arts or hotel management program or at a county vocational school or post-secondary educational institution, provided, however,

that this Ordinance shall not be construed to preclude the imposition of a penalty under this Ordinance, R.S. 33:1-81, or any other section of law against a person who is convicted of unlawful alcoholic beverage activity on or at premises licensed for the sale of alcoholic beverages.

SECTION 2: REPEALER: All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.

SECTION 3: SEVERABILITY: If any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance, but shall be confined in its effects to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in a controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

SECTION 4: EFFECTIVE DATE: This Ordinance shall take effect immediately upon final adoption and publication and in the manner provided by law.
